- 1. This is not a permit.
- 2. Please include the following documents with your application form. Incomplete application forms will not be processed. Depending on the nature of your application, you may be required to submit additional information. Please include with this application:
 - i. This complete Application Form
 - ii. Application Fee
 - iii. Map showing the location of the tree(s)
 - iv. Written consent from the property owner if the applicant is NOT the property owner
 - v. If the municipal tree is bordering two properties, written consent from the adjacent property owner must be provided
- 3. Typical processing time for applications is a maximum of 30 working days from the submission of a complete Application. The length of time to process the application may be impacted if additional information is required, multiple trees are being reviewed or the Municipal Tree Removal Application is to be reviewed in conjunction with other development applications. Incomplete applications will not be processed resulting in delays and will restart the process initiation time.
- 4. Municipal address must include street name and number. (911 numbers for rural location)
- 5. Submit this application and supporting documentation to the Municipal Offices, 395 Mulock Drive, Newmarket ON L3Y 4X7 or by email to info@newmarket.ca. Once your application is submitted, please call the Town of Newmarket at 905-895-5193 to make a payment for the application. Applications will not be processed until payment is made.
- 6. Once the application has been approved, the Town of Newmarket will contact you to pick-up the permit and pay the appropriate compensation fees (if applicable) prior to receiving the permit.
 - a. Compensation fees are as follows:
 - i. 200% of the appraised value of each tree to be removed plus an administrative fee.
 - ii. The cost of the Town's contractor to remove each tree, as set out in the Fees and Charges By-law plus an administrative fee.
 - iii. The cost of the Town's contractor to remove the stump of each tree, as set out in the Fees and Charges By-law plus an administrative fee.

Permit Review

The permit review will consider the following:

- All work must be in compliant with good arboricultural practices
- All work must be in compliant with the Town's Tree Protection policies and other standards as required by the Town
- All compensation fees for the removal be paid by the applicant.
