



CORPORATION OF THE TOWN OF NEWMARKET

BY-LAW NUMBER 2010-61

A BY-LAW TO ADOPT FEES AND CHARGES FOR SERVICES OR ACTIVITIES PROVIDED BY THE TOWN OF NEWMARKET.

(General Fees and Charges, Licensing Fees – Legislative Services)

WHEREAS the *Municipal Act, 2001* authorizes a municipality to pass by-laws imposing fees and charges for services or activities provided or done by or on behalf of it;

AND WHEREAS Council enacted By-law 2009-100 to establish a General Fees and Charges, and Licensing Fees for Legislative Services;

AND WHEREAS it is deemed necessary to enact a new by-law setting out the General Fees and Charges and Licensing Fees for Legislative Services of the Town of Newmarket.

THEREFORE BE IT ENACTED by the Municipal Council of the Corporation of the Town of Newmarket as follows:

1. THAT the attached Schedules A and B marked as the Town of Newmarket Legislative Services Fees and Charges and Licensing Fees Schedules, respectively, form part of this by-law;
2. AND THAT should any section of this by-law be declared invalid by a court of competent jurisdiction, such section shall be construed as being severed herefrom and the remainder of the by-law shall continue in full force and effect;
3. AND THAT notwithstanding fees and charges and licensing fees prescribed in other legislation, this by-law supersedes all other Legislative Services fees and charges and licensing fees previously established by the Town of Newmarket for the services identified in this by-law;
4. AND THAT this by-law shall be known as the General Fees and Charges, and Licensing Fees By-law for the Legislative Services;
5. AND THAT this by-law shall come into full force and effect on January 1, 2011 at which time By-law 2009-100 be repealed.
