VOLUNTEER SERVICE AWARDS

VOLUNTEER PROGRAM LEADER

Criteria – Leaders of programs in Newmarket that have dedicated their time, skills, leadership and experience to enable a program to grow and expand in our community.

SPONSOR / CONTRIBUTOR AWARD

Criteria – For those providing financial support and/or personal support to enhance the operations of a community program / service.

RAYMOND J. TWINNEY MEMORIAL YOUTH AWARD

Criteria – Youth 24 years and under that have given their time and dedication to enhance the quality of life for Newmarket residents.

HERB CAIN MEMORIAL AWARD

Criteria – Individuals 25 years and over that have made a distinct contribution to sports in Newmarket.

EXECUTIVE BOARD MEMBER

Criteria – An individual that is instrumental in the success of community groups or associations. Leaders that contribute to the improvements and achievements of their group(s).

ENVIRONMENTAL AWARD OF MERIT

Criteria – Individual(s) / organization(s) that have made a significant contribution for the preservation and conservation of our environment and green space with in Newmarket.

COACH / ORGANIZER AWARD

Criteria – Coaches / organizers of sports, cultural and community activities that by sharing their time enhance the programs / activities of a local organization or group in our community.

ARTS, HERITAGE AND CULTURE AWARD

Criteria – An individual who has made a significant contribution to the enhancement of community arts, heritage and culture.

CITIZEN OF THE YEAR AWARD

Criteria – An individual who resides in the Town of Newmarket and has served our community in an outstanding manner for many years.
