My understanding is that there is no requirement to report as Newmarket Hydro Holdings Inc. is not a local board.

Under the Municipal Act, a local board is:

“local board” means a municipal service board, transportation commission, public library board, board of health, police services board, planning board, or any other board, commission, committee, body or local authority established or exercising any power under any Act with respect to the affairs or purposes of one or more municipalities, excluding a school board and a conservation authority; (“conseil local”)

Regulation 599/06 to the Municipal Act

Status of corporation

21. (1) A corporation is not a local board for the purposes of any Act. O. Reg. 599/06, s. 21 (1).

I am not aware of any definition for “body”

As you know, 284(3) of the Municipal Act 2001 Act says a statement shall be provided to a municipality:

“If, in any year, any body, including a local board, pays remuneration or expenses to one of its members who was appointed by a municipality, the body shall on or before January 31 in the following year provide to the municipality an itemized statement of the remuneration and expenses paid for the year.”
